Sealed BIDS for construction of a New Video Surveillance System will be received by the Housing Authority of the Borough of Cliffside Park, 500 Gorge Road, Cliffside Park, New Jersey until 10:00 am, Friday December 17, 2010 at which time they will be publicly opened and read aloud.

The project consists of the installation of a server-based digital Video Surveillance solution and cameras throughout its buildings at its campus located at 500-550 Gorge Road Cliffside Park, New Jersey 07010. The purpose of this document is to request a proposal for a solution based on the criteria outlined within this BID package.

A Bid Bond provided by an accredited bonding source in the amount of 10% of the Total Base Bid is required.

A mandatory pre-bid meeting and walk through of the site will be held at 10 am, Friday December 10, 2010, at the Housing Authority of the Borough of Cliffside Park, 500 Gorge Road, Cliffside Park, New Jersey. The mandatory pre-bid meeting will include a walking tour of the project site.

Plans, specifications in the form of a Request for Proposal and contract documents may be examined at KP Johnson & Associates offices 15 Mendham Road, Gladstone, New Jersey on Wednesday December 1, 2010 between 9am and noon. Copies of the plans, specifications and contract documents may be obtained from KP Johnson & Associates for a non-refundable charge of \$125.00 on Friday December 3, 2010. The bid package will include one set of 24"x36" drawings, a project Request for Proposal (RFP) and a CD with the drawings and project RFP in PDF format.

This solicitation for bids may be canceled by the Housing Authority of the Borough of Cliffside Park, and any bid or proposal may be rejected in whole or in part for good cause when in the best interests of the Housing Authority of the Borough of Cliffside Park. The Housing Authority of the Borough of Cliffside Park reserves the right to reject any or all proposals or accept what is, in its judgment, the best bid.
